Sub: Nomination for election to the vacancies in the Council for 2020

Dear Member,

The process of election to the Council for 2019 is going to start as per Sub-Clause nos. 24.4, 25.5, 25.7, 34.2, 34.3, 34.4 and 34.5 (by e-voting) respectively of the Constitution (Rules & Regulations) of the Institute.

Some important information related to the election are given below:

1. Vacancies in the Council for 2018 in terms of Sub-Clause 24.4/25.5 would be as follows:

Eastern	1 (One)	Northern	2 (Two)
Southern	2 (Two)	Western	1 (One)

2. As required in sub clause 34.4 nominations are invited in prescribed manner from amongst the eligible corporate members. The names, membership category and membership number of corporate members who are eligible to nominate, second and vote in the Annual Election appear in the Electoral roll. Out of these corporate members, those having membership numbers 1 to 54295 (both inclusive) and also having served in the Executive Committee of any Regional Centre for at least two years, are eligible to contest for election to the Council as Member subject to the restrictions as stated hereunder. The members abroad may not nominate, second or stand for election to the Council, but they may vote (in due course) in the election.

3. The following members will continue in the Council under the Rules and need not be nominated:
